Summary of Reporting Requirement

Included in the Manager's Agreement to H.R. 1865, which became Public Law 116-94, the Further Consolidated Appropriations Act, 2020, (page 167) was a request for a report to update the Committees on Appropriations, including the name of each organization receiving funding in fiscal year 2020; the amount of each award; a summary of each project; and a projected timeline for each project:

Health Disparities.—The Committee includes an increase of \$13,202,000 above the amount requested in the fiscal year 2020 budget request and directs OMH to allocate the additional funds for research or public health interventions related to Sickle Cell [Disease], Sickle Cell Trait, Lupus, Alzheimer's, Diabetes, and peripheral artery disease, as well as stomach, liver, and cervical cancer to help reduce the racial and ethnic disparities that exist in these diseases. The Committee encourages OMH to support research at Historically Black Colleges and University medical colleges and Hispanic Serving Institution medical schools to explore the disproportionate impact these diseases have on minority populations. The Committee directs OMH to submit an update to the Committees on Appropriations no later than September 30, 2020, including the name of each organization receiving funding in fiscal year 2020; the amount of each award; a summary of each project; and a projected timeline for each project.

The following report summarizes the fiscal year (FY) 2020 awards of the U.S. Department of Health and Human Services (HHS) Office of Minority Health (OMH) based on OMH's Congressional appropriation of \$58.6 million.

Executive Summary

In fiscal year (FY) 2020, the HHS Office of Minority Health (OMH) funded 96 organizations in total to support new and continuing demonstration initiatives and other public health activities that support the reduction of health disparities in racial and ethnic minority populations. These awards totaled more than \$43.3 million and addressed a variety of areas, including, but not limited to: (1) supporting states, territories and tribes in identifying and sustaining health equity promoting policies, programs and practices in varied prevention and clinical condition topics; (2) expanding the utilization of community health workers to address health and related needs within communities; and (3) strengthening cultural competence among healthcare providers.

FY 2020 New Awards

In FY 2020, OMH issued notices of [grant] funding opportunities (NOFOs) and contract acquisition requests and entered into intra-departmental delegations of authority (IDDAs) and inter-agency agreements (IAAs) to support 11 demonstration initiatives and other public health activities. These new awards totaled more than \$18.1 million.

New Grants

OMH funded five new grant initiatives with 39 awardees and a total budget of more than \$15.9 million. These awardees have the following characteristics:

- Areas of focus: adverse childhood experiences, HIV, maternal mortality, lupus, diabetes (which can be related to peripheral artery disease), physical activity, nutrition, substance use disorder, sickle cell disease, cardiac arrest, and the prevention of liver and cervical cancer.
- Geographic scope: national scope and state-specific scope for 20 states and the District of Columbia: Alabama, Arkansas, California, Connecticut, Florida, Georgia, Maine, Maryland, Michigan, Missouri, New York, North Dakota, Nebraska, New Mexico, Ohio, Tennessee, Texas, Utah, Vermont and Wisconsin.
- Organizational type: (1) 17 community-based organizations; (2) nine academic institutions, including one historically black college and university (HBCU); (3) seven state/local governments; (4) four hospitals; (4) one Native American Tribal organization; and (5) one non-profit Tribal serving organization.

New Contracts

OMH funded four new contracts with a total budget of more than \$1.4 million. The areas of focus for these awards are: community health aides; language translation service; and OMH organizational development.

New Intra-departmental Delegations of Authority and Inter-agency Agreements

OMH funded two new IDDAs and IAAs with two Federal government partners and a total budget of \$750,000. The areas of focus for these awards are: lupus and sickle cell disease.

Awards Addressing Clinical Areas Noted in the FY 2020 Congressional Appropriations Report

The FY 2020 Congressional Appropriations Report directed OMH to allocate funds for research or public health interventions related to the following areas: sickle cell disease and trait, lupus, Alzheimer's, diabetes and peripheral artery disease; and stomach, liver, and cervical cancer.

OMH's FY 2020 new awards that specifically address these clinical areas are as follows:

- State/Tribal/Territorial Partnership Initiative to Document and Sustain Disparity-Reducing Interventions (grant)
- Sickle Cell Disease (SCD) Clinical Data Collection Platform (grant)
- Demonstration to Increase Hydroxyurea Prescribing for Children with Sickle Cell Disease Through Provider Incentive (grant)
- SCD Training and Mentoring Program for Primary Care Providers (STAMP) (IDDA)
- Diversity in Lupus Clinical Trials Initiative (IDDA)

Of note, OMH's State/Tribal/Territorial Partnership Initiative NOFO included the opportunity for grant proposals addressing Alzheimer's and stomach cancer, but OMH received no applications focused in these clinical areas.

FY 2020 Continuation Awards

In FY 2020, OMH issued continuation funding for grants, contracts, IDDA's and IAAs to support 15 demonstration initiatives and other public health activities. The continuation awards totaled more than \$25.2 million.

Continuation Grants

OMH funded seven continuation grant initiatives with a total of 43 awardees and a total budget of more than \$16.3 million. These awardees have the following characteristics:

- Areas of focus: youth physical activity; hepatitis B prevention and treatment; opioid abuse prevention, treatment and recovery; historical trauma within American Indian/Alaska Native (AI/AN) communities; youth violence prevention; healthcare access and utilization, healthcare workforce diversity, and data utilization in health equity activities; and transition processes for individuals moving from jail back into communities.
- Geographic scope: national scope and state-specific scope for the following 26 states: Alaska, Arizona, California, Connecticut, Florida, Georgia, Illinois, Indiana, Kansas, Kentucky, Massachusetts, Maine, Michigan, Missouri, New Jersey, New Mexico, New York, Ohio, Oregon, Pennsylvania, Rhode Island, South Dakota, Virginia, Vermont, Washington, and Wisconsin.
- Organizational type: (1) 19 community-based organizations; (2) 12 academic institutions, including one HBCU and one Hispanic serving institution (HSI); (3) five city/county/state governments; (4) three Tribal serving organizations; (5) three Native American Tribes; and (6) two hospitals.

Continuation Contracts

OMH funded six continuation contracts with a total budget of more than \$7.4 million. The areas of focus for these awards are: sickle cell disease; OMH Resource Center; Think Cultural Health Center for Linguistic and Cultural Competence in Health Care; technical and logistical support for the Advisory Committee on Minority Health and other OMH activities; and evaluation of OMH-funded grants and cooperative agreements and Think Cultural Health e-learning curricula.

Continuation Intra-departmental Delegations of Authority and Inter-agency Agreements

OMH funded one continuation IDDA and one IAA with two Federal government partners and a total budget of approximately \$1.5 million. The areas of focus for these awards are: sickle cell disease and Healthy People.

These awards support projects to help build the capacity of state, tribal, and territorial health agencies to achieve two main goals: (1) test modifications to existing public health programs or practices (interventions) to assess if the modified interventions are successful in significantly improving health outcomes for selected health issues; and (2) develop an effective plan(s) to sustain successful interventions after the award period. Projects are expected to address two health issues, one from each of the following two lists: (1) HIV, maternal mortality and morbidity, physical activity, or substance use disorder; and (2) nutrition, sickle cell disease and trait, diabetes, Alzheimer's, lupus, or cancer prevention (i.e., addressing a risk factor(s) specifically for stomach, liver, or cervical cancer).

Of note, OMH did not receive any grant applications addressing Alzheimer's and stomach cancer.

These awards seek to determine whether implementation of earned income tax credit (EITC) outreach and education activities in communities at higher risk for adverse childhood experiences (ACEs) can result in: (1) increased EITC receipt; and (2) changes in risk and/or protective factors for ACEs. OMH expects projects funded under this initiative to: (1) establish multi-sectoral partnerships to support EITC outreach and education activities in communities at higher risk for ACEs; (2) plan and implement EITC outreach and education activities in communities at higher risk for ACEs; (3) develop and implement a process and outcome evaluation plan; (4) communicate and disseminate findings, successes and lessons learned; and (5) plan for sustainability of successful interventions.

This award seeks to determine whether a standardized sickle cell disease (SCD) clinical data collection platform, shared across medical centers and other healthcare facilities, can serve as a central repository for analyzing data from large patient cohorts, recruiting patients for clinical trials, assessing adherence to evidence-based clinical guidelines, and identifying new areas for research. OMH expects the awardee to develop and implement a SCD data collection platform and to create and manage a collaborative learning community of participating clinical care teams and patient/family members to pilot utilization of the shared data collection platform. The long-term vision and ultimate goal of this learning community is to improve patient care and outcomes, including improved quality of life, for individuals with SCD and their families and to reduce the cost of care.

Demonstration to Increase Hydroxyurea Prescribing for Children with Sickle Cell Disease Through Provider Incentives

This award seeks to demonstrate the feasibility and effectiveness of providing financial incentives to providers to improve the quality of life of children with SCD through increased prescription rates of hydroxyurea. OMH intends for the awardee to build the capacity of the State Medicaid Office and other partners to achieve three main goals: (1) develop performance measures for hydroxyurea prescribing for the three main provider types that care for children with SCD (i.e., hematologists, primary care providers, and emergency clinicians); (2) develop and implement an incentive payment system(s) for each provider type; and (3) evaluate the effectiveness of financial incentives for providers to increase hydroxyurea prescribing and decrease emergency department visits for children with SCD.

These awards seek to demonstrate whether participation in an out-of-hospital cardiac arrest (OHCA) registry, using standard data collection tools and data infrastructure, supports the: (1) identification of racial and ethnic minority and/or disadvantaged populations experiencing cardiac arrest; and (2) implementation of evidence-informed interventions to improve cardiac arrest survival rates.

The awardees will implement state-level processes for contributing to an OHCA data registry, including data collection on emergency cardiac care by emergency medical services and outcomes through hospital discharge. Using data from the OHCA registry, awardees will describe the state cardiac arrest occurrence rate by race and ethnicity and other related factors. The initiative ultimately will enhance the capacity of state health agencies to implement and sustain evidence-informed interventions that significantly improve health outcomes of individuals who experience OHCA.

STAMP is a pilot program developed by the HHS SCD Workgroup and the HRSA SCD Treatment Demonstration Program. STAMP supports targeted outreach to primary care providers and advanced practice providers and their participation in case-based training and

mentorship sessions on the clinical care of individuals with SCD. The training sessions are delivered via the Project ECHO (Extension of Community Healthcare Outcomes) platform. The STAMP sessions will be part of a broader SCD certificate training program for primary care providers.

The mission of TCH is to collaborate with federal agencies and other public

and private entities to enhance the ability of healthcare professionals and students to effectively deliver linguistically appropriate and culturally competent healthcare to diverse populations.
